ORDINANCE 2024-10-23 (Levy Ordinance)

WHEREAS, applicable statues require the Library District to adopt a levy ordinance levying taxes for Library purposes upon all property subject to taxation within the District, and

WHEREAS, pursuant to applicable statutes, a Budget and Appropriation Ordinance was previously adopted, published, and filed.

Section 1: The Budget and Appropriation Ordinance for the fiscal year 2024-25 is incorporated by reference.

Section 2. A tax in the sum of ONE MILLION, SEVEN HUNDRED AND SEVENTY THOUSAND NINE HUNDRED TWENTY FOUR DOLLARS AND ZERO CENTS (\$1,770,924.00) is levied as follows:
